

## Shriram Housing Finance Wins 'Best Housing Finance Company of the Year - 2022' Award



**MUMBAI, September 12** – Shriram Housing Finance Limited (SHFL), part of the Shriram Group, won the award for 'Best Housing Finance Company of the Year -2022' at the 4th Annual India NBFC Summit & Awards, organized by Quantic India in September 2022.

won the award for its remarkable growth, advancement in technology, people-friendly practices and being an industry leader in the housing finance space over the last fiscal year.

SHFL has assets under management of Rs 5,355 crore and had undergone a transformation phase in 2018, posting asset growth of a whopping 36% in FY22 compared with the industry average of 8%. The disbursements were higher by 25% on year at Rs 2,739 crore for FY22—the highest ever annual disbursements—supported by strong growth momentum. Sustained improvement in the quality of the portfolio, coupled with high collection efficiency, has led to strong demand for the company's housing loans and loans against property.

The company is poised to double its AUM in two years with an AUM target of Rs 10,000 crore by FY24. In FY22, enthused by the improved business metrics of SHFL, the promoter infused Rs 500 crore of growth capital and NHB approved refinance worth Rs 500 crore. This will help fuel the company's growth ambitions over the next 2-3 years.

The affordable housing finance sector is on the cusp of long-term secular growth, because of favourable macros, low-interest rates, revival in residential real estate and thus improved affordability. Shriram Housing Finance has the stage set and is poised to be among the top 3 players in the affordable housing finance space. The demand for housing has revived to a significant extent, especially from smaller towns, and the overall tailwinds are positive now.

SHFL was recently certified as a 'Great Place to Work' for February 2022-2023.
